

EXPORTATION OF CINEMATOGRAPH FILMS TO NAURU.

PROCLAMATION

Australia to wit.
R. M. FERGUSON,
Governor-General.

By His Excellency the Governor-
General of the Commonwealth of
Australia.

WHEREAS by the *Customs Act 1901-1916* it is, amongst other things, enacted that in time of war the Governor-General may, by Proclamation, prohibit the exportation of any goods, and that the power above mentioned extends to authorize the prohibition of the exportation of goods generally or to any specified place, and either absolutely or so as to allow of the exportation of the goods subject to any condition or restriction:

Now therefore I, Sir Ronald Craufurd Munro Ferguson, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby prohibit the exportation of Cinematograph Films from the Commonwealth of Australia to Nauru, unless the consent, in writing, of the Minister of State for Trade and Customs has first been obtained.

Given under my Hand and the Seal of the Commonwealth, at Melbourne, this sixth day of November, in the (L.S.) year of our Lord One thousand nine hundred and eighteen, and in the ninth year of His Majesty's reign.

LICENCE

Australia to wit.

WHEREAS by a Proclamation relating to Trading with the Enemy, issued by His Majesty the King on the ninth day of September, One thousand nine hundred and fourteen, and published in the *Commonwealth of Australia Gazette* of the twelfth day of September, One thousand nine hundred and fourteen, it is, amongst other things, declared that nothing in that Proclamation shall be taken to prohibit anything which shall be expressly permitted by licence given by His Majesty or by the licence given on behalf of His Majesty by a Secretary of State or the Board of Trade whether such licence be especially granted to individuals or be announced as applying to classes of persons:

And whereas by a further Proclamation issued by His Majesty the King in Council on the eighth day of October, One thousand nine hundred and fourteen, and published in the *Commonwealth of Australia Gazette* of the twelfth day of October, One thousand nine hundred and fourteen, it is, amongst other things, provided that the power to grant licences on behalf of His Majesty vested by the first-recited Proclamation in a Secretary of State may be exercised in Australia by the Governor-General:

And whereas a Licence in regard to remittances to persons in Palestine, applicable to persons resident in the United Kingdom, has been issued by the Lords Commissioners of His Majesty's Treasury, and it is desirable that a similar Licence should be issued in regard to persons resident in the Commonwealth:

Now therefore I, Sir Ronald Craufurd Munro Ferguson, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby authorize all persons resident, carrying on business, or being in the Commonwealth, notwithstanding anything contained in paragraph 5 of the Imperial Trading with the Enemy Proclamation, No. 2, to pay any sums of money to or for the benefit of any persons resident in Palestine subject to the following conditions:—

1. All payments made in pursuance of this Licence must be made either through the Post Office attached to His Majesty's Forces operating in Palestine, or through Messrs. Thomas Cook & Son, or some branch of the Imperial Ottoman Bank, or of the Anglo-Egyptian Company Ltd., or of the Anglo-Palestine Company Ltd., for the time being authorized by or on behalf of the British Government to carry on business in Palestine; and

2. The written permission of the Minister for Defence for the remission of moneys to enemy subjects or naturalized persons who have at any time been enemy subjects must be obtained in accordance with Regulation 64B of the War Precautions Regulations.
