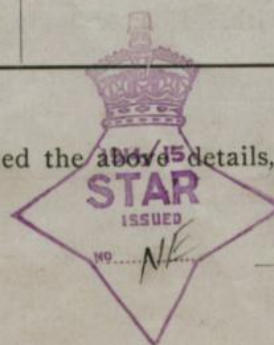

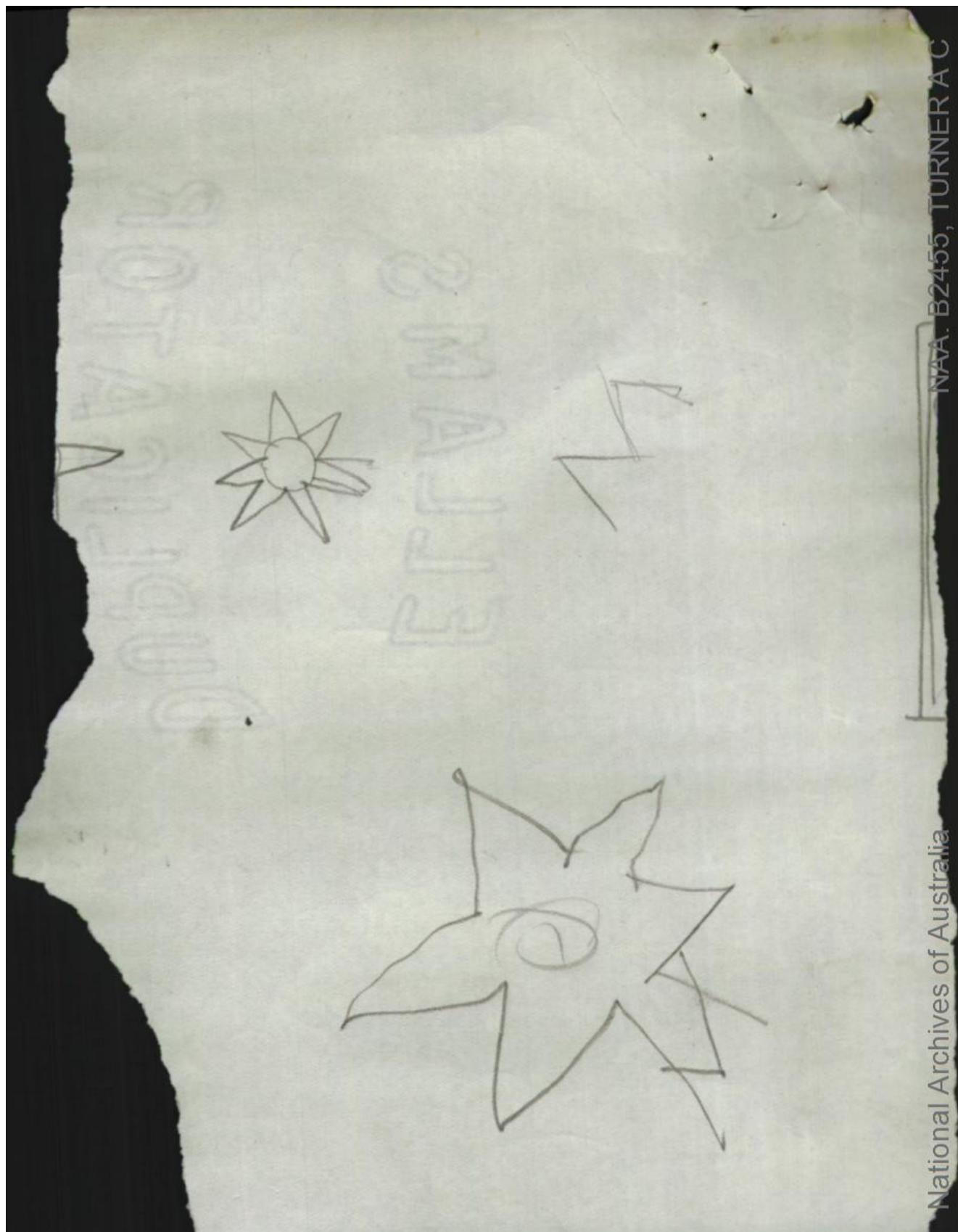

Sir,

Will be glad if you can give me information as to the date and complaint that I came out of the line with, on the Somme front, as the fact that I am still under treatment here with dysentery; is not sufficient proof for my lodge authorities to pay me sick pay.

I came out of the line just to the right of Jones Wood facing Papune, about as far as I can remember the 25th of Nov. 1916, with diarrhoea and slight trench feet, I was only in the line five days, three in the support trench, called Needle Trench, being close by Needle Dump which then was a first dressing station; and two days in the front line; my P. C. was a Capt Mills.

I was sent back to the Rouen, No. 5 Gen. Hosp from there to the base at Etaples to the 26th Gen Hosp. Etaples and sent to England on the 12th Jan 1917. to the Canadian Hosp. Upington. Kent. from there to the No. 1. A. A. Hosp. Harefield Middlesex & left England on May 4th, arrived here on July 1st.

I have already sent my lodge secretary a written declaration, signed by the M. C. of this

ward to the effect that I came out of the line about the 25th of Nov 1916, with slight trench feet and dysentery, and am still under treatment for dysentery.

I am enclosing his reply which will explain why I am writing you, for official confirmation of date when illness commenced etc.

I left here with the 7th Pz Div, on the 27 June 1916.

I am enclosing stamps for reply & trust you can oblige.
