The Board having assembled pursuant to order, proceeded to take evidence:-

LIEUT.COLONEL A. M. BRAZIER, states:-

After referring the matter to the 3rd. Light Horse Brigade Headquarters, he ordered the 10th. Regiment, which he commands, to assault in 2 lines the Turkish trenches on the NEK, in an easterly direction from our trenches on Russells Top, although at this time, there was a murderous hail of shrapnel, machine gun and rifle fire from the enemy, and felt quite convinced few if any would return. He has personally seen with a periscope, a great number of dead outside our trenches, and has caused the recovery of all those bodies, which up to the present he considers wise to risk further loss of life for.

He is of the opinion that all the missing are dead, and further from the reports of the wounded who returned to the lines, and from personal observation with
