He was of A. or D.Coy. at Passchendaele on 12th Oct. early in morning, our attack had gone about 200 yds. I was 60/70 yds. away when I saw him blown to pieces, along with 2 other men that were near him. I passed the spot several times during the day, all that was to be seen, pieces of cloth and pieces of remains. We made a search over the ground later, not finding anything to identify any of them - was well know, Christian name Don, mate of mine, There was no burial.

In further answer to your enquiry for -

1875 Pte. D. McLeod. 37th Battalion. A.I.F.

We regret to inform you of unofficial evidence given by 1942 Pte. C. Callaghan of the same unit who was interviewed recently at the Anzac Buffet, London. Informant who is a stretcher bearer stated that he was about 50 yards distant from your brother when he saw him killed instantly with two other men who were close by by a shell.

They had advanced about 200 yards in their attack at Passchendaele early in the morning of 12-10-17 when the casualty occurred and informant passed the spot several times during the day and says that ~~his~~ ^{McLeod's} body was not buried.

We are continuing our enquiries and as soon as further information is received we shall advise you.

Trusting that it will be some consolation to know that his death was instantaneous.
