I am in receipt of your further letter dated 10th instant, and have to state that your previous communication requesting the address of your son, Private J. C. 
It is regretted the Department cannot suggest a method of effecting delivery to your son of the parcels and letters referred to, but you will understand that the origin of the error was the lack of necessary particulars in your inquiry.
