Andrew Clifford Phillip Williamson

Gunner (Gnr) 34068 Andrew Clifford Phillip Williamson enlisted in the Field Artillery Brigades reinforcements in Melbourne on 22 January 1917. He embarked overseas on 11 May and disembarked in Plymouth, England on 20 July, where he joined the Reserve Brigade Australian Artillery (RBAA) at its Larkhill Camp for the next six weeks.

He proceeded overseas to France on 11 September, where he was taken on strength of the 6^{th} Field Artillery Brigade, in the field at Zillebeke, Belgium, on 17 September, where they supported the 1^{st} and 2^{nd} Division's successful assault from Menin Road on 20 September.

After a week or two out of the line, the brigade returned to Zillebeke and provided artillery fire support for the first two weeks of November, after which Third Ypres wound down, and they took over the line near Kemmel for several weeks.

During late March 1918, the brigade was operating near Messines, when it regularly came under German counter battery fire. During one of these bombardments, Gnr Williamson was gassed on 23 March 1918, evacuated, and admitted to the 35th General Hospital at Calais a week later.

He embarked for England on 8 April, where he was hospitalised at the 2nd Southern General Hospital in Bristol until 7 May, after which he was granted leave until 21 May 1918.

He also spent a month at the 1^{st} Northern General Hospital in Newcastle from 23 July -24 August (no details given) and returned to the RBAA on 6 September.

He then contracted influenza and was further hospitalised at the Military Hospital at Sutton Veny for five weeks between 2 November – 10 December 1918. He never returned to France and boarded a ship for Australia on 19 February 1919.

Gunner 34068 Andrew Clifford Phillip Williamson disembarked in Melbourne on 7 April, where he was formally discharged from the AIF on 10 September 1919.
