Alan Dunn

Private (Pte) 2172 Alan Dunn enlisted in the 46th Infantry Battalion in the 12th Infantry Brigade of the 4th Australian Division in Melbourne on 2 May 1916.

He embarked overseas on 16 August and disembarked in Plymouth on 2 October, where he joined the 12th (Brigade) Training Battalion at Codford Camp.

While there, he was absent without leave between 20 - 25 October, for which he was awarded 21 days Field Punishment No. 2 (extra work duties) and docked 21 days' pay, and then again on 22 November, for which he was awarded seven days confined to camp and the loss of one days' pay.

He sailed for France on 4 December and disembarked the next day, where he joined the 4th Division Base Details at Etaples. While there, he was charged with breaking out of the Segregation Camp on 4 January 1917, for which he was awarded the loss of 28 days' pay.

Pte Dunn left Etaples on 25 January and was subsequently taken on strength of the 46th Battalion, in the field at Mametz, two days later, one of 110 reinforcements received that day.

The 46th Battalion moved into the front line near Gueudecourt on 9 February, and it was here a week later that Pte Dunn sustained a shrapnel wound to his right hand on 16 February.

He was evacuated and admitted to the 1st General Hospital at Rouen from 17 February – 2 March, then sent to a convalescent depot, also in Rouen, until 12 March, when he was discharged to the 4th Division Base Details Camp at Etaples.

He never rejoined his battalion but instead returned to England on 9 April and was attached to the No. 2 Command Depot at Weymouth. After three months there, he embarked for return to Australia on 22 July.

Private 2172 Alan Dunn disembarked in Melbourne on 27 September, where he was medically discharged from the AIF on 2 November 1917.
