





A claim has been submitted to CPM C Comd by Miss Iris Trenerry in respect of the service of SFX 13419 Sister A.M. Trenerry (deceased).

2. The particulars held by the Command Pay Office show that the member became missing on 14 Feb 42 and for official purposes presumed dead, death whilst POW confirmed vide Casualty List \$1046 of 26 Jan 45.

3. A perusal of schedules of POW of the Japanese does not disclose the name of the abovementioned.

4. It is requested that the details of the service of the abovenamed be examined and advice forwarded, please.
