I saw the above (all of B Coy) and one other man whose name, I think, was Lionel killed by one shell near Beauvoir about 7 a.m. during the attack about 1/2 hour or less after we hopped over. I was stretcherbearing & was following up behind them and was not 5 yards from them. Browning (killed instantly) was hit through head, Clarkson (instantly) thigh to knee badly smashed and concussion, Sgt. Crockett (instantly) piece through chest - chopped pay-book in half, Monchmore (instantly) all over body, Lionel (instantly) head, Langley hit on left collar bone and the artery was cut he was the only one with any life and I tried to dress the wound and succeeded in stopping the bleeding but he was dead before I finished so that he also was killed practically instantly (within 5 minutes). The shell burst right among them and the concussion was terrific. I was within 5 yards but the shell burst away from me. We were relieved that night - they were left there.

Browning - Dark, tall, about 30 years
Clarkson - Tall, dark, getting a little bald, should think over 30 years.

B. Coy. 28th Batt. A. I. F.
who has been killed in action sometime between the 3rd & 10th of October. We have received no official notice as this would be sent to his wife in W. Australia, the only information we have being from friends of my brother in the same division, but these friends were not actually with him at the time.

I should be very very grateful if you could find out how he was killed, the date, & if possible where is his grave. It seems so terrible not even to know where

he was buried or whether the spot
is marked.

the following unofficial report from Pte.V.A.Coe. 28th Battn.
A.I.F. He stated that he saw Pte."Bob"Browning killed instantly
by a shell while crossing No man's Land near Bullecourt On
Oct.3rd/1918. He was only 25 yards away when the casualty
occurred. Pte.Coe described him as being dark, 5'10" in
height, about 35 and a married man.

We are continuing our enquiries and will obtain
further particulars.

In further reference to your enquiry for 7392 Pte. B.M. BROWNING, 28th Batta. A.I.F. We beg to inform you that we have received an unofficial report from 6578 Cpl. I.R. Flower of the same Unit. He stated that he saw Pte. Browning and several other men killed by a shell at Beaufort about 7 p.m. during an attack on 3.10.19. Cpl. Flower was acting stretcher bearer that day and was only 5 yards off when the casualty occurred. Pte. Browning was killed instantaneously being wounded by a piece of shell in the head. Cpl. Flower described him as tall, dark and about 30 years old, and it was his first time in the line. It was read out in orders that he was buried by the English in the Cemetery at Mont St. Martin the grave registration number being sheet 62.R.H.24.C.5.7.

We are continuing our enquiries and will advise you should we obtain further particulars.

With reference to your enquiry for 7392 Pte. E.M. BROWNING. 28th Battalion. A.I.F. We beg to inform you that we have received an unofficial report from 6578 Cpl. L.R. Flower of the same Unit, who was acting as stretcher bearer and stated that he saw Pte. Browning and several other men killed by a shell in an attack near Beurevoir at about 7 a.m. The casualty occurred about an hour after the "hop over" and Pte. Browning was wounded in the head and killed instantly. Our informant was not present at the burial he described. Pte. Browning as tall, and dark, aged about 30 Years. From the Battalion Orderly Room they report that Pte. Browning was buried by the English 25th Divisional Burial Officer at Mt St. Martin Cemetery, the map reference being Sheet 62 B.H.24.c.9.7. We are doing our utmost to obtain further particulars and will advise you immediately should we succeed.
